In addition, it looks at the legal system in the context of race, class, and gender and considers multicultural and cross-cultural issues in a contemporary and interdisciplinary context.

Temario oposición a Gestión de Estado (Turno libre ) - Sardón Gall 2022-02-23

En época de crisis aumenta el número de personas que se presenta a una oposición. Si se consigue una plaza, los afortunados se asegurarán un empleo o, en otros casos, tendrán la opción de formar parte de una bolsa de trabajo a la cual las instituciones recurren para cubrir bajas o puestos con carácter temporal. Una de las claves del éxito es la preparación previa, ya que de ella dependerá en gran medida el resultado. Los cuatro aspectos fundamentales son: informarse de la convocatoria, conseguir el temario de la oposición, revisar exámenes anteriores para familiarizarse con ellos y cumplir los requisitos exigidos, en cuanto a titulación o formación. Cada vez más personas se plantean las oposiciones como medio para lograr un puesto de trabajo. Con la tasa de desempleo en aumento, aprobar estos exámenes se convierte en la meta de ciudadanos en paro o que quieren mejorar su estatus profesional. Sin embargo, a la par que aumenta el número de interesados, descienden las plazas ofertadas. El primer paso para inscribirse en una oposición es conocer su convocatoria. El Boletín Oficial del Estado es una fuente de información fundamental, aunque diversas páginas web cuentan también con buscadores de oposiciones, muy prácticos para acceder a esta información. Conocer las diferentes convocatorias permite establecer prioridades: qué vacante interesa más. Por otro lado, aunque la convocatoria de oposiciones ha descendido, puede ocurrir que una misma persona se interese por varias convocatorias y que estas coincidan en fechas. Si los exámenes se realizan el mismo día, habrá que elegir entre todas. Estudiar el temario de cada oposición es fundamental. Por ello, es indispensable conseguir la materia por la que se preguntará en las pruebas. Es habitual que si se acude a una academia para preparar los exámenes, en el centro entreguen todos los apuntes necesarios. En la propia convocatoria publicada en el BOE se especifica el temario de cada oposición. A menudo se editan manuales con los temas de los exámenes, pero en ocasiones, los opositores deben hacerse con los temas por su cuenta. Internet es una fuente muy importante de recursos. Algunas páginas web están especializadas en áreas concretas de oposición. Nada mejor que contar con exámenes de convocatorias anteriores para conocer las preguntas y los aspectos a los cuales se da más importancia. En las academias se facilitan exámenes para practicar y poner a prueba el conocimiento de cada uno de los temas. Conviene familiarizarse con los exámenes tipo test e intentar realizarlos en el mismo tiempo del que se dispondrá en la prueba. La preparación ha de ser lo más real posible para lograr un resultado óptimo el día del examen. Algunos test son específicos, referidos al contenido del temario (sanidad, administrativo, etc.), mientras que otros, como los test psicotécnicos, son generales. Para presentarse a las oposiciones es necesario cumplir unos requisitos. En ocasiones, se exige contar con una titulación específica o formación en un campo concreto. Otras veces, es necesario obtener ciertos certificados que acrediten el dominio de un área, como el uso de tecnologías de la información. El perfil del opositor ha cambiado. Si antes eran las personas más jóvenes (entre 18 y 25 años) quienes se decantaban en mayor medida por esta opción, ahora la edad media ha aumentado (entre 26 y 35 años). Por sexo, ellas son mayoría. Entre quienes opositan, hay tanto personas desempleadas que buscan un trabajo como personas empleadas que aspiran a conseguir un mejor puesto. No obstante, ser opositor es casi una profesión, ya que a menudo exige dedicar varias horas de estudio cada día y acudir varios días a la semana a una academia. Estos centros se caracterizan por ayudar al opositor con la materia de estudio, resolver dudas e informar de cualquier cambio en la convocatoria. Los buscadores son una vía muy adecuada para conocer la convocatoria de plazas. La vida del opositor se ve notablemente alterada por la preparación de las pruebas, se pueden superar oposiciones para puestos como subalternos, auxiliares administrativos o administrativos estudiando entre nueve meses y un año. "Las oposiciones del grupo A (dirigidas a personas con título de doctor, licenciado, ingeniero, arquitecto o equivalente) requieren unos dos años de preparación. No obstante, hay aspirantes que aprueban en un tiempo inferior y otros que lo consiguen en siguientes convocatorias". Además, una vez aprobada la oposición, hay trámites que seguir y no siempre se logra un puesto de forma inmediata. La documentación se debe presentar dentro de un plazo, después se solicitará el destino. El número uno de la convocatoria, el que mayor puntuación haya logrado en la oposición, podrá elegir entre todos los destinos, pero al último le corresponderá la última plaza en el destino que haya quedado vacante. Aquellos opositores que hayan aprobado los correspondientes exámenes pero no hayan conseguido plaza debido a la puntuación, pasarán a engrosar la bolsa de trabajo y serán ellos los primeros en ser convocados

para cubrir vacantes temporales, bajas y cualquier otro tipo de necesidad que surja en el cuerpo al que han optado. Todas las oposiciones tienen en común temas de Organización del Estado (Constitución Española) y temas de Derecho Administrativo. El resto del temario variará en función del tipo de plaza a la que se opte y de la comunidad autónoma que saque las plazas. Las que exigen mayor preparación, dirigidas a titulados superiores, son las que menos competencia presentan pero también las más duras de preparar, tanto por la cantidad de la materia a estudiar como por su dificultad. Los programas pueden sufrir alguna modificación de una convocatoria a otra, pero lo habitual es que el conjunto de temas no cambie, con lo que la preparación realizada sirve para sucesivas convocatorias. Los procedimientos de selección incluyen pruebas diversas: ejercicios de temas de conocimientos generales o específicos (orales, escritos o ambos), test psicotécnicos, entrevistas, pruebas para valorar conocimientos de idiomas. Al menos uno de los ejercicios de la oposición ha de ser práctico. Se puede estudiar en casa, consiguiendo el material por medios propios (a través de Internet o de algún conocido) o solicitando cursos a distancia. Estos últimos incluyen envío de material, tutorías (por correo, fax, teléfono o Internet), orientación y guía y ejercicios prácticos. La opción de preparar los exámenes en casa exige una organización ejemplar, adquirir hábitos de estudio, fuerza de voluntad a raudales y, sobre todo, disponer de medios para obtener la información necesaria (fechas, temarios, cambios). Otra alternativa es acudir a una academia. Las clases impartidas en estos centros sirven para adquirir hábitos de estudio y marcar un ritmo en la preparación, a la vez que aclaran dudas y permiten realizar exámenes tipo para familiarizarse con las pruebas finales. Estos centros proporcionan información actualizada, ayudan a resolver dudas y facilitan exámenes de oposiciones anteriores. También avudan a los opositores a percatarse de la escala de importancia de la materia, es decir, a otorgar a cada temario la importancia que tiene. Las clases se adaptan a todo tipo de horarios (mañana, tarde, noche e incluso sábados). La razón es que parte de sus alumnos trabajan y dedican su tiempo libre a preparar estas oposiciones. El porcentaje de aprobados de los alumnos que optan por las academias es alto, ronda el 70%-75%, aunque antes de decidirse por una u otra academia es importante comparar precios y trayectorias de cada una de ellas, una academia es una herramienta para aprobar las oposiciones. "Queda en mano del alumno saber utilizarla. No basta con las dos horas que pasa aquí, necesita al menos una hora diaria de estudio en su casa para no perder el contacto con la materia", la ayuda que oferta una academia comienza en el momento de asesorar al alumno en la elección de la que puede ser la mejor oposición, la que más se ajusta a su formación previa y a sus circunstancias personales. En definitiva, la que tenga más posibilidades de aprobar. Los puestos de funcionario de la administración se engloban en diferentes niveles reflejando así al grupo de profesionales que lo constituyen. Para acceder mediante oposición a cualquiera de los cinco grupos (A, B, C, D y E) es necesario saber qué formación exige cada uno de ellos: El nivel A: Corresponde al Cuerpo Superior de Administradores del Estado. Para acceder a las oposiciones de estas plazas es necesario tener título de Doctor, Licenciado, Ingeniero, Arquitecto o equivalente. Los puestos que se ofertan en este grupo son los de técnicos de administración, directores? El nivel B: Es el Cuerpo General de Gestión de la Administración Civil del Estado. Se precisa Título de Ingeniero Técnico, Diplomado Universitario, Arquitecto Técnico, Formación Profesional del Tercer Grado o equivalente. Estos profesionales pasan a ocuparse del cuerpo de gestión, con puestos de jefes de departamento, por ejemplo. El nivel C: Para aquellos en posesión del Título de Bachiller, Formación profesional de Segundo Grado o equivalente. Trabajan como administrativos. El nivel D: Título de Graduado Escolar, Formación Profesional de Primer Grado o equivalente. Son los llamados auxiliares administrativos. El nivel E: Apto para los que tengan el Certificado Escolar. Este es el grupo del cuerpo de subalternos, celadores, conserjes, bedeles? Las oposiciones de nivel E y D son las que más competencia presentan, dado que, al requerir menos titulación, el número de gente que opta a ellas es muy elevado. A las oposiciones para alcanzar niveles superiores se presenta menos gente, aunque los exámenes son más complicados. Dentro del Grupo o Nivel A, la media de temas por oposición es de 120-140, en el Grupo B de 50 a 65, el C 40-50 y el D en torno a los 10-12 temas El Cuerpo de Gestión de la Administración Civil del Estado tiene como funciones las tareas de gestión administrativa y apoyo de nivel intermedio comunes en la actuación de la administración. Las pruebas selectivas para el ingreso libre al Cuerpo de Gestión de la Administración Civil del Estado consisten en tres ejercicios y un curso selectivo posterior desarrollado en el Instituto Nacional de Administración Pública. El proceso selectivo para

el acceso por promoción interna, para personal funcionario y personal laboral fijo, al Cuerpo de Gestión de la Administración Civil del Estado consiste en una fase de oposición, que consta de dos ejercicios, y una fase de concurso. Los aspirantes que superen la fase de concurso-oposición tendrán que participar en un curso selectivo de formación desarrollado en el Instituto Nacional de Administración Pública. El temario se compone de las siguientes materias: Organización del Estado y de la Administración Pública Unión Europea Políticas Públicas Derecho Administrativo General Administración de Recursos Humanos Gestión Financiera y Seguridad Social No obstante, se recuerda al opositor que los temas no agotan el contenido del programa de la oposición y se aconseja estudiar consultando los textos legales.
